Core Functionality Overview - CHARMS(™)

Foster Carer/Adopter Recruitment

Website Enquiries:

A link to the council website enquiry form allows new prospective carer enquiries to be added to CHARMS with an email sent to the recruitment team alerting them to the new enquiry, Mailing lists can be setup and tailored so that groups of carers and prospective carers may be contacted by SMS/Email. Any such contact is automatically added to the relevant case files.

Adopter/Foster Carer Assessment

CHARMS has the CoramBAAF PAR/Form F built in. CHARMS reports on the progress of each assessment and Fostering/Adoption team. QA staff can monitor it on an ongoing basis and even exchange notes/comments with assessors in a secure, controlled way. *NO Word files exchanged with anyone, ever*. Adopter/foster carer progress is tracked automatically and every adopter/foster carer at enquiry, stage 1, stage 2, panel, approval and beyond can easily be identified and reported upon.

Foster Carer/Adopter & Children Registers & Trackers

These are available at the click of a button.

Vacancy Lists

Are always on, live, 24/7, and one click away from the Main Menu.





Secure Prospective Foster Carer/Adopter Application (ROI) Form

Instead of the traditional paper or Word/PDF form - with scores of questions of a highly sensitive nature - CHARMS has an in-built application form, in line with the registration of interest requirements. Prospective foster carers/adopters are given permission to login and complete the form. They can save it and return to complete it over time. Social Workers and others can see progress.

Adopter/Foster Carer Profiles

Always up-to-date and easy to share to facilitate the best placement as quickly as possible..

Secure Panel Member Access (Free of charge!)

Panel members access this highly sensitive, personal information only in CHARMS. *NO printed papers*.

Secure Independent Assessor Access (Free of charge!)

Assessors access the Form F/PAR only in CHARMS.

Full Chronology Of Significant Events (Linked Progress)

A unique approach has been implemented which offers agencies a simple and accurate way to track the chronology of activities following any significant event, in children or family files.

Secure Foster Carer Access (Free of charge!)

Carers have their own portal to login and view progress and to complete their daily logs which can then be digitally verified by the social worker securely. They can also upload paperwork e.g. birth certificates, insurance documents. And finally they can record actions on the child's file e.g. dentist visits and incidents. Respite carers can login to view important information about the child such as medical needs, dietary, allergies - *NO papers are exchanged and NO emails are sent*.





Secure Adopter access (Free of charge!)

Adopters too have their own portal to login and view progress with their assessment and to upload paperwork e.g. birth certificates, insurance documents. And when a child is in placement awaiting adoption order the adopters can record updates on the child's file e.g. health visits and incidents. <u>NO papers are exchanged and NO emails are sent</u>.

Secure Young People Login

Children placed may share information and ask questions, record thoughts and life story logs. At annual review time in fostering the young people may make their contributions securely and quickly using their own, secure <u>CHARMS YP Login</u>.

Secure, Encrypted Email Portal

All files/reports from CHARMS may be shared with third parties securely using 2 stage login. No expensive email sharing systems required. The CHARMS Portal is free for everyone.

Ofsted Reporting

The Ofsted Fostering Dataset data is generated from CHARMS.

ASGLB/List 11 Reporting

All generated from CHARMS quickly and with no fuss.

Secure Ofsted Inspector Access

Inspectors may be given a dedicated user account to enable them to login and look in detail at case files.

Find-a-Family and Find-a-Child

A complete and effective matching system, first developed in 1999. On the click of a button, upon referral of a child, the best potential matches with foster carers/adopters are identified.





Postcode Searches

Quickly locate families, on a map, within a given radius filtered by approval terms – ethnicity, age, matching considerations...

Potential Links

These are recorded quickly and easily and can be shared, securely with adopters and foster carers who can then digitally verify that they have seen them. Nothing is saved on foster carers own computers. GDPR and data protection are paramount.

Staff Management

A complete HR/staff management system – built in to CHARMS. But not just staff – panel members, independent assessors, third parties. Track recruitment from start to finish. Monitor sickness/absence, annual leave, Police checks, training, supervisions, appraisals and just about everything else. Staff and panel member registers are included in the reporting suite. The Bradford Factor is used to help manage sickness.





Auto Email of Incidents

CHARMS allows all actions to be set up so that when recorded an auto email can be sent to designated people. NO sensitive data/information is sent in the email - just a simple alert to login to CHARMS to see key tasks/incidents allocated to the recipient.

Adopter/Carer/Staff/Children Training Management

All training is managed in a unique, dedicated module in CHARMS. When carers login they can see which courses they are booked on - <u>and which training sessions</u> <u>they failed to attend...</u>

OMG - Online Mail Grabber

A unique facility to "grab" emails from any email client and save them to the carer, child or staff members' case files.

SMS

Individual or grouped text messages may be sent to carers and staff and the details are stored in each individual case file.

Reporting

all regulatory reports can be generated. All customers can ask for new reports at any time and they are built <u>free of charge</u>. A full assessment checklist is generated showing where all prospective adopters/carers are up to.

System Developments

All developments are funded by SCN. No customer pays for any developments.

Cost

CHARMS cost £85 per month per concurrent licence. Expenses only are charged for setup, training data import etc.

Example

Small IFA/LA fostering service with 50 families, 15 staff, 60 children placed. 9 x licences @£100 each per month (plus VAT) = £900 per month. Implementation, training, data import, support, – **free of charge**.

This enables foster carers to be clear about advice or direction given to them by supervising social workers during visits. Leaders and managers have close links with the software manufacturer and are able





to influence positive changes in the system. All users have access to technical support to assist when problems occur."
